Rate Increase Notice – January 1, 2025

In keeping with its commitment to public health and system reliability, The Municipal Authority of Washington Township (MAWT) has approved a \$4 per month increase in the capital improvement fee for water customers. Minimum usage and consumption rates will remain the same. The Board of Directors has authorized the rate increase to become effective on January 1, 2025.

MAWT has taken steps to hold its costs down and improve efficiency. These steps include replacing old waterlines, refurbishing our water tanks, and applying for grants for necessary water plant upgrades and line extensions.

MAWT applied for and was awarded a FY 2024 Washington County Local Share grant of \$250,000 to replace the waterline on Lynn Street in Roscoe. The contract was awarded to Britton & Sons, the low bidder in the amount of \$341,812.29. Work is scheduled to begin in early December.

MAWT also applied and was awarded a FY 2024 Community EPA Grant of \$500,000 for plant improvements including complete upgrade of the 4 filters, motor control center, SCADA monitoring system, and waterline replacements in Jefferson Estates (Jefferson, Washington, and Coolidge), Grove, Sandbank, Hoffman, Perry, Gillespie Hollow Road, Perry to Connellsville Rd, and Connellsville To Third Street. The grant will be combined with a low interest PennVest loan of \$4.7 million. Those upgrades are planned for 2025.

MAWT also applied for FY 2025 grants for vehicle replacements and upgrading our metering system. Those grants will be awarded in 2025.

Clean, safe water is essential for any community. We believe the investments we are making will provide customers with reliable water service, better fire protection, and a reduction in repairs and maintenance costs to the Authority and ultimately, it's customers.
